School Trustee Report - March 19, 2019

Swan Hills teacher selected as Edwin Parr nominee

Swan Hills teacher Michelle Tran has been selected by the school board as this year's nominee for the Alberta School Boards Association (ASBA) **Edwin Parr Teacher Award**, which recognizes first-year teachers for their outstanding efforts. Each school board can only nominate one candidate to the zone selection committee. This year, the school board received principal recommendations for two very deserving first-year teachers for this provincial award.

School bus fly-by statistics are up 40%

It is illegal to pass a school bus when the red lights are flashing — the fine is \$543 and six demerit points. Last school year the division transportation office received a whopping 123 reports of fly-by incidents (35 in-town, 88 rural). So far in the first half of this school year, 85 fly-bys have been reported (30 in-town, 55 rural)—that's almost 40% more than last year.

Provincial proposed Policy Position Statement

This week the Board will be considering whether or not to submit a policy position statement for all provincial school boards to vote on in the fall. If successful it would then be used to advocate government to review the current law. Pembina Hills will be proposing "That the Minister of Transportation establish that school buses may operate at the same speed as the posted speed limit, as prescribed by law."

Alberta is the only province that has a transportation regulation that states that school buses can only travel 90km/h or the posted speed limit, whichever is less. This means that school buses that travel on major highways in the province could be travelling 10-20km/h slower than the moving traffic around them. It can be a safety hazard to travel lower than the posted speed limit as you are more likely to cause or be involved in a crash than a vehicle moving at a normal speed. When school buses are on roads with faster moving traffic bus drivers report that motorists perform unsafe passing maneuvers, inappropriate hand gestures, honking and expletives.

A change in regulation to allow buses to travel the posted speed limit would address safety concerns, and have a positive impact on bus ride times. For example, in Pembina Hills Public Schools when looking at data that compared what our bus ride times might look like if our buses could travel the posted speed limit we could save approximately seven hours a day off our ride times. If you multiply 7hours x 184 school days that is equal to 1,288hours in a school year! This is significant time that students can spend in other ways and in other environments.

Alberta Rural Education Symposium

I attended this conference at the beginning of March and it was great to have a mix of trustees, senior administration, principals, municipal councilors and government ministers and staff present all talking about rural issues in education and the need for community partnerships. Despite the statistics we heard on the aging population and decline in rural areas, we also heard great stories about school partnerships that connect us to one another. Small towns and schools build relationships, and this is an advantage of rural living.
