#### 4. Old Business

- a) CTF Update a parent presented a possible new CTF option for Junior High. GIS (Global Information Systems). We will visit the possibility in the new school year depending on what happens with the COVID situation. There is a possibility of doing day workshops for things like carpentry, knitting, crocheting, possibly with the local senior group. Doris Kuelken would be willing to do a CPR/First Aid course with the kids. Another option would be to include a Hunter Education course. The kids will be asked if they would like to go forward with this, either on a weekend or possibly doing it online.

There will be refunds sent out to parents who pre-paid for spring classes. Trying to do google meets with preschool children is a huge challenge!
- g) Communication/ Welcoming Committee Report Crystal Wood There was a table set up at the first evening of Parent/ teacher interviews to inform parents about the Parent Society and Parent Council roles in the school. It was a success, just did not get to see all the parents because before the next evening of interviews Schools were all shut down due to COVID 19. An idea to do a biography of all the Teachers and Support Staff in the school was presented so that new parents coming into the school would know a little bit about the people in the school. Also, thought this would be a way to implement security within the school, by knowing who everyone is.
- h) Additional discussion a teacher brought up concerns about students transitioning back into school after such a long time being away. Alberta School Council Association put out a survey to parents asking about the 3 different scenarios for School Re-entry. At this time, the results of that survey are not known. Mental health is a big concern in children due to the pandemic and current lockdown procedures in place. Rural students have a huge advantage in comparison to urban children. We are all hopeful that the kids needing help are reaching out for the help they need.
